Acuité has reviewed the long-term rating of '**ACUITE B+** (**read as ACUITE B plus**) on the Rs. 10.00 crore bank facilities of G M REDDY COTTON INDUSTRIES PRIVATE LIMITED. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Incorporated in 2010 GM Reddy Cotton Industries Private Limited (GMRCIPL) is a Warangal based company promoted by Mr. Gandra Bhoopal Reddy and family and is engaged into cotton ginning and pressing business. The current installed capacity of the company is 250 bales/ day.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
