Rating Rationale

Acuité has reviewed the long-term rating of '**ACUITE BB-**' (read as **ACUITE double B minus**) and short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) on the Rs.5.70 crore bank facilities of Spring INC. This rating is now an indicative rating and is based on best available information.

Spring Inc. was established as a partnership firm in 2005 by A. Shanmugam. The firm is involved in production of garments and exports the same to UK, USA, France and Ireland.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
