Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 7.50 Cr bank facilities of Sri Bangar Srinivas Agro Foods. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Sri Bangar Srinivas Agro Foods established in 2006, promoted by Mr. R P Govindraj and Mr. R P Krishnamurthy is Raichur, Karnataka based firm is engaged in the business of processing of paddy and rice milling. The firm procures raw materials like paddy from the farmers nearby, located in Raichur, Karnataka. The firm is having a capacity of milling 128 tonnes of paddy per day and currently the firm is producing 27331 tons per annum.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
