Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 9.20 Cr bank facilities of Keechery Engineering CO. (KEC). The rating continues to be flagged as "Issuer NotCooperating" and is based on the best available information.

About the Company

The Chennai-based, Keechery Engineering Co (KEC) is a proprietorship firm established in 1997 by Mr. Sudhakar. KEC undertakes interior decoration contracts. The firm has ceased the supply of medical equipment and now undertakes services for the medical equipment supplied. The operations are spread across Tamil Nadu, Kerala, Karnataka and Andhra Pradesh with reputed clients such as Blue Star, Ford Motor Company and KPMG India Private Limited, among others.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavored to gather information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
