Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf)rom 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short-term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs. 9.20 Cr. bank facilities of Keechery Engineering CO. (KEC) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Chennai-based, Keechery Engineering Co (KEC) is a proprietorship firm established in 1997 by Mr. Sudhakar. KEC undertakes interior decoration contracts. The firm has ceased the supply of medical equipment and now undertakes services for the medical equipment supplied. The operations are spread across Tamil Nadu, Kerala, Karnataka and Andhra Pradesh with reputed clients such as Blue Star, Ford Motor Company and KPMG India Private Limited, among others.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating.
