Rating Rationale

Acuité has reaffirmed the long-term rating of '**ACUITE D' (read as ACUITE D)** and short-term rating of '**ACUITE D' (read as ACUITE D)** on the Rs. 28.00 crore bank facilities of Florind Shoes Private Limited (FSPL). The rating continues to be flagged as "Issuer Not Co-operating" and is based on the best available information.

About the Company

Florind Shoes Private Limited (FSPL), incorporated in 1978 is engaged in the manufacturing and export of leather and craft shoes. The manufacturing facility is located at Ambur, Tamil Nadu with an installed capacity of around 2500 pairs of shoes per day. Directors of Florind Shoes Private Limited are K Ameenur Rahman, Kandrikar Shahid Mansoor.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuité endeavoured to gather information about the entity / industry from the public domain.
