Acuité has reviewed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 8.00 crore bank facilities of Mysore Enterprises (ME). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Mysore Enterprises (ME), a partnership firm established in 1980 by Mr. Anil Kumar Agarwal is engaged in the processing of iron and steel scrap is located in Bengaluru. The firm is led by the founding partner, Mr. Anil Kumar Agarwal.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
