Acuité has downgraded long-term rating to '**ACUITE D**' (**read as ACUITE D**) from '**ACUITE C**' (**read as ACUITE C**) to the Rs. 15.00 crore bank facilities of Mobicule Technologies Private Limited (MTPL). This rating is now an indicative rating and is based on best available information.

Mobicule Technologies Private Limited (MTPL) is a Mumbai-based software company incorporated in 2008 by Mr. Siddharth Agarwal and Mrs. Ruchi Agarwal. The company provides customized software solutions for inventory management, loan disbursal, and lead generation among others. It caters to various industries including FMCG, electronics, cement, fertilizer and paints. The company has offices at Mumbai, Delhi, Pune and Hyderabad.

Non-cooperation by the issuer/borrower

Acuité has downgraded its rating on the bank facility of Mobicule Technologies Private Limited (MTPL). The downgrade of ratings is on account of continuous overdrawings in cash credit account for more than 30 days.

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
