Acuite has reviewed the long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) and short term rating of '**ACUITE A4**' (read as **ACUITE A four**) to the Rs.19.00 crore bank facilities of Mahadev Yarns Private Limited (MYPL). This rating is now an indicative rating and is based on best available information.

MYPL, incorporated in 1991, was promoted by Mr. Ram Kishan Mundhra and Ms. Pushpa Devi Mundhra. The company is engaged in the manufacturing of texturised, non-sized and roto-yarns at Kosamba (Gujarat). MYPL has an installed capacity of 6000 tonnes per year. The utilisation stands at around 4600 tonnes per month.

Non-cooperation by the issuer/borrower: Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
