### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE BB' (read as ACUITE double Bf)rom 'ACUITE BB+' (read as ACUITE double B plus)on the Rs.17.00 crore bank facilities of AVK Ispat Private Limited (AIPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

### **About the Company**

Mumbai-based, AVK Ispat Private Limited (AIPL) was established in 2010. The company is engaged in the trading of non-prime flat steel products such as sheets, hot rolled/cold rolled coils, galvanized coils & plates. The board of directors includes Mr. Vimal Sewda and Mr. Kamal Sewda.

## Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
