Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B (read as ACUITE B)**' from '**ACUITE B+ (read as ACUITE B plus)**' on the Rs. 11.00 crore bank facilities of Bangalore Metallurgicals Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Bangalore Metallurgicals Private Limited was established in 1960 as a partnership firm and later, changed to private limited in 1987. The company is engaged in the manufacture of cast iron and ductile iron and has installed capacity of 600 tons per month. The company is led by Mr. Ramaiah Raghavendra and his two sons, Mr. Rakshith Raghavendra and Mr. Rajith Raghavendra. The manufacturing facility is located at Hosakote (Bangalore).

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
