Acuite has reviewed long-term rating of '**ACUITE B-**' (read as **ACUITE B minus**) on the Rs. 10.00 crore bank facilities of B. NANJI A (BNA). This rating is now an indicative rating and is based on best available information.

Established in 2010, BNA is an Ahmedabad-based partnership firm engaged in the development of commercial and residential projects in and around Ahmedabad (Gujarat). Currently, the firm has undertaken construction of a residential project 'India Colony' comprising 540 flats and 77 bungalows at Ahmedabad.

Non-cooperation by the issuer/borrower

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
