Rating Rationale

Acuité has reaffirmed the long-term rating of **'ACUITE B-' (read as ACUITE B minus)** n the Rs.10.00 crore bank facilities of B. Nanji A (BNA). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Established in 2010, B. Nanji A is an Ahmedabad-based partnership firm engaged in the development of commercial and residential projects in and around Ahmedabad (Gujarat). The firm is led by Partners, Mr. Ashish Bhupendrabhai Patel, Mr. Biren Bhupendrabhai Patel, Mr. Prashant Pravichandra Amin, Mr. Ishwarbhai Parshotamdas Patel, Mr. Mayur Ishwarbhai Patel, Rakeshbhai C. Patel who have more than two decades of experience in the construction industry. Currently, the firm has undertaken construction of a residential project 'India Colony' comprising 540 flats and 77 bungalows at Ahmedabad.
