Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE Bf**) from '**ACUITE B+**' (read as **ACUITE B plus**) and reaffirmed the short term rating of '**ACUITE A4**' (read as **ACUITE A four**) on the Rs. 9.00 crore bank facilities of Rheoplast Technology Private Limited (RTPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

The Mumbai-based, Rheoplast Technology Private Limited (RTPL), was promoted by Mr Parminder Kohli and Mr. Preetpal Singh Kohli and others in 2009. The company manufactures construction chemicals such as concrete admixtures, engineering grouts, waterproofing systems and surface treatment systems to name a few. The offices are located at Mumbai, Gurgaon, Bangalore and Kolkata.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
