Rating Rationale

Acuite has downgraded the long-term rating to ‘**ACUITE B-**’ (read as **ACUITE B minus**) from ‘**ACUITE B**’ (read as **ACUITE B**) on the Rs.5.40 crore bank facilities of Mukesh Fabtex on account of information risk. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Mukesh Fabtex (MF), a proprietorship concern was established in 2001 by Mr. Mukesh Kumar S. Jain, Proprietor. The Maharashtra-based firm is engaged in the manufacturing of grey fabric and has around 72 weaving machines. The total production capacity is around 90000 metres per annum. The firm outsources dyeing of cloth.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
