Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 6.00 crore bank facilities of Subbiah Matches (SM). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

SM is a Tamil Nadu based firm, established in 2007 by Mrs. Veeralakshmi Subburaj. The firm is engaged in manufacturing of cardboard wax stick matchboxes and cardboard wooden stick matchboxes. It has two facilities located at Vembakottai road and Padanthai in Sattur with installed capacity of 4000 bundles per day. The firm sells products under the brand names 'Speed', 'Ped', 'Baskar', 'Raja', 'Punkat' and 'Umbrella'.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower).
