Rating Rationale

Acuite has reaffirmed the long term rating to '**ACUITE BB**' (read as **ACUITE double B**) on the Rs. 10.00 crore bank facilities of Krishna Enterprises (KE). The rating continues to be flagged as "Issuer Not-Cooperating" and is reaffirmed on account of information risk.

About the Company

Krishna Enterprises was established in the year 1991 by Mr. Devendra Seth located in the Faridabad district of Haryana. Currently, his sons, Mr. Ajay Seth and Mr. Sanjay Seth, look after the business. Mr. Ajay Seth looks after the commercial aspect of the business and Mr. Sanjay Seth looks after the technical aspect of the business. The firm is engaged in the manufacturing of machine components used in the engineering sector. The company has its own manufacturing facility where it has the capacity and resources to manufacture 700 different types of components based on the specification and customization set by the client.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
