Rating Rationale

Acuite has downgraded its long term rating to '**ACUITE D**' (read as **ACUITE D**) from '**ACUITE B+**' (read as **ACUITE B plus**) & short term rating to **ACUITE D** (read as **ACUITE D**) from **ACUITE A4** (read as **ACUITE A four**) on the Rs 6.50 crore bank facilities of M G Industries. The rating continues to be flagged as "Issue Not Cooperating". The downgrade is on account of default as recognized from CIBIL suit filed account for the bank loan facilities availed from Central Bank of India.

About the Company

MGI, established in 1981 by Mr. Kanaiyalal Changrani, is engaged in the manufacturing of precision components, electrical and pneumatic tools for automobiles at Nashik (Maharashtra). The firm led by the second generation entrepreneurs, Mr. Kunal Changrani, Mrs. Reena Changrani and Mr. Sagar Changrani, caters to a reputed client base. The raw materials are procured domestically.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity/industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
