**Rating Rationale**

Acuite has reaffirmed its long-term rating of '**ACUITE D' (read as ACUITE D&)** short-term rating of '**ACUITE D' (read as ACUITE D)** on the Rs 6.50 crore bank facilities of M G Industries. The rating continues to be flagged as "Issuer Not Cooperating" and is based on best available information.

**About the Company**

M G Industries, established in 1981 by Mr. Kanaiyalal Changrani, is engaged in the manufacturing of precision components, electrical and pneumatic tools for automobiles at Nashik (Maharashtra). The firm led by the second generation entrepreneurs, Mr. Kunal Changrani, Mrs. Reena Changrani and Mr. Sagar Changrani, caters to a reputed client base. The raw materials are procured domestically.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
