Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 16.95 crore bank facilities of Ridham Texport Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Ridham Texport Private Limited is based in Mumbai, it was incorporated in the year 1997. The company is promoted by Mr. Chetan Bafna and Mrs. Reshma Bafna. It is engaged in the manufacturing of cotton fabrics. The company has its manufacturing unit at Boisar, Thane. The company has total of 63 Weaving Machines and has production capacity is of 150,000 Meters per month.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
