**Rating Rationale**

Acuite has reaffirmed the long-term rating of '**ACUITE B+**' (read as **ACUITE B Plus**) and the short-term rating of '**ACUITE A4**' (read as **ACUITE A Four**) on the Rs.12.50 Crore bank facilities of Vitech Equipments Private Limited (VEPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

**About the Company**

Vitech Equipments Private Limited (VEPL) is a Mumbai-based company incorporated in 2003. Promoted by Mr. Charles D'Souza, VEPL is engaged in the manufacture of heat exchangers, pressure vessels, silos etc. The installed capacity stands at 15,000 MTPA.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

**Limitation regarding information availability:**

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather information about the entity / industry from the public domain. Therefore, Acuite cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
