**Rating Rationale**

Acuite has reaffirmed the long-term rating of ‘**ACUITE B-**’ (read as **ACUITE B minus**) on the Rs. 18.00 Cr. bank facilities of Morgan Milk And Dairy Industries Private Limited. The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

**About the Company**

Morgan Milk And Dairy Industries Private Limited is a Nashik based company incorporated in 2014, promoted by Mr. Samadhan Hire and Mrs. Rekha Hire and engaged in manufacturing and processing of milk based products such as milk powder, ghee, butter, paneer and flavoured milk sold under the brand name 'Morgan Milk'. The commercial operations have commenced from November 2018.

**Non-cooperation by the issuer/borrower:**

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.

**Limitation regarding information availability**
