Acuité has reviewed long-term rating of **ACUITE B+** (**read as ACUITE B plus**) on the Rs. 27.00 crore bank facilities of Gajraj Textiles Limited (GTL). This rating is now an indicative rating and is based on best available information.

GTL, incorporated in February 2014, is promoted by Mr. Hem Raj, Mr. Bhanu Partap Singla, Mr. Anil Kumar Gupta and Mr. Pankaj Gupta. The promoters possess extensive experience in the cotton yarn industry and plan to set up a cotton yarn manufacturing unit at Patiala (Punjab).

#### Non-cooperation by the issuer/borrower
