Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE Bf**) from '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 27.00 crore bank facilities of Gajraj Textiles Limited (GTL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Samana based Gajraj Textiles Limited (GTL) was incorporated in February 2014. It is promoted by Mr. Hem Raj, Mr. Bhanu Partap Singla, Mr. Anil Kumar Gupta and Mr. Pankaj Gupta. The company is engaged in the production of textile yarn. It is an open end unit, having 3432 rotors, manufacturing 100% cotton yarn with count range 7NE to 30NE.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
