### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B)from 'ACUITE B+' (read as ACUITE B plus)and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four)on the Rs. 18.00 crore bank facilities Maruti Products Private Limited (MPPL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Jaipur based, Maruti Products Private Limited (MPPL) was incorporated in the year 2010 by Mr. Varun Kumar Agarwal and Mr. Akhilesh Kumar Agarwal. The company is engaged in the business of manufactures of steel billets.

#### Non-cooperation by the issuer/borrower:
