#### **Rating Rationale**

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B)from 'ACUITE B+' (read as ACUITE B plus)and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs.34.50 Cr bank facilities of Shri Vasudeva Weaving Mills Private Limited on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

#### About the Company

Shri Vasudeva Weaving Mills Private Limited incorporated in 2012 by Mr. E. N. Sivasamy (Promoter), is a Coimbatore based company engaged in weaving of fabrics along with trading of cloth. The commercial operations however started in 2015. The count ranges from 60's to 100's cotton for suiting fabrics and 30's to 120's cotton for shirting and bottom weight fabrics. Sri Vasudeva procures cotton yarn from Andhra Pradesh and Tamil Nadu. The company caters to reputed clients in Andhra Pradesh, Tamil Nadu, Gujarat and Delhi. The company has an installed capacity of 96 lakh meter per annum. The Company has a second hand windmill purchased in the year 2016 of 3.75 MW the power of which is internally used. The company generates revenue from manufacturing of fabrics, organic fabrics, and viscose fabric.

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
