Rating Rationale

Acuité has downgraded the long-term rating to '**ACUITE B-**' (read as **ACUITE B minus**) from '**ACUITE B**' (read as **ACUITE B**) on the Rs. 11.00 crore bank facilities of Alpha Print Management Solutions (APMS) on account of information risk. The rating continues to be flagged as "Issuer Not Co-operating" and is based on the best available information.

About the Company

Bangalore based, Alpha Print Management Solutions (APMS) was established in 2015 by Mr. Majid Yusuf Patanwala, Mrs. Hawa Majid Patanwala and Mrs. Nailah Majid Patanwala. The firm is a distributor for Hewlett-Packard (HP) printer ink cartridges and directly caters to wholesale and retail traders. APMS procures mainly from Ingram Micro India Private Limited, Redington India Limited, and Savex Technology Private Limited.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
