Rating Rationale

Acuite has reaffirmed the long-term rating of '**ACUITE B**' (read as **ACUITE B**) and the short term rating of '**ACUITE A4**' (read as **ACUITE A Four**) on the Rs. 7.00 Crore bank facilities of Ashirvad Polysac Private Limited (APPL). The rating continues to be flagged as "Issuer Not Cooperating" and is based on the best available information.

About the Company

Ashirvad Polysac Private Limited (APPL), established in 1990 under the directorship of Mr. Gopalkrishna Shenoy, is currently managed by his son, Mr. Goutham Shenoy. APPL is engaged in manufacturing of Woven Sacks, which are used for packaging pesticides, fertilizers, cement, and food grains, among others at Mangaluru, Karnataka.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and noncooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.
