Rating Rationale

Acuite has reaffirmed the long term rating of '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs.35.00 Cr bank facilities of Patel Inn and Travels Private Limited (PITPL). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Ahmedabad based, Patel Inn And Travels Private Limited was incorporated in 2006 by Ms. Hiruben Khetani, Mr. Meghijibhai Khetani and Mr. Gaurang Khetani. PITPL operates as a travel operator covering more than 15 routes in major cities such as Saurashtra in Gujarat, Mumbai, Pune, Shirdi, and Kolhapur among others with a fleet of around 270 buses including Volvo, Scania, Tata and Ashok Leyland. Buses are booked on a contractual basis by corporate clients such as Adani, Welspun, Kohler, ABG Cement Ltd., GRG Cotspin, RMG Alloys Steel Ltd etc. and also used as passenger travellers.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating continues to be flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.

Limitation regarding information availability:

The rating is based on information available from sources other than the issuer/borrower (in the absence of information provided by the issuer/borrower). Acuite endeavored to gather

information about the entity/industry from the public domain. Therefore, Acuité cautions lenders and investors regarding the use of such information, on which the indicative credit rating is based.
