Acuite has reviewed short term rating of '**ACUITE A4+**' (read as '**ACUITE A four plus**') to the Rs. 6.50 crore bank facilities of Key Tech Engineering Company (KTEC). This rating is now an indicative rating and is based on best available information.

KTEC is a proprietorship concern established in 1996 by Mr. Pravin Kushalraj Mehta. The firm is engaged in the manufacture of specialised valves, pipes and fittings, stainless steel among others, mainly used in the chemical and fertiliser industries. The registered office is located at Andheri (Mumbai) and the manufacturing facility at Vasai in Palghar (Maharashtra).

Non-cooperation by the issuer/borrower

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
