Rating Rationale

Acuité has downgraded the short term rating to 'ACUITE A4' (read as ACUITE A four) from 'ACUITE A4+' (read as ACUITE A four plus) on the Rs. 6.50 Crore bank facilities of Key Tech Engineering Company (KTEC) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Key Tech Engineering Company (KTEC) is a proprietorship concern established in 1996 by Mr. Pravin Kushalraj Mehta. The firm is engaged in the manufacture of specialized valves, pipes and fittings, stainless steel among others, mainly used in the chemical and fertilizer industries. The registered office is located at Andheri (Mumbai) and the manufacturing facility at Vasai in Palghar (Maharashtra).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower). Acuite endeavoured to gather information about the entity/industry
