Rating Rationale

Acuite has downgraded the long-term rating to '**ACUITE B**' (read as **ACUITE B**) from '**ACUITE B+**' (read as **ACUITE B plus**) on the Rs. 10.00 crore bank facilities of Sri Gowri Cashew (SGC) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Sri Gowri Cashew was established in 2006 by Mr. Mohandas Hegde. The company is in the processing of cashews into cashew kernels, shells, cashew husk and rejects. It imports cashews from South Africa, Nigeria, Singapore, and other African Countries and sells the processed product domestically in Maharashtra, Gujarat, and Punjab. The capacity of the company is approximately 90 bags (80 kg) each per day. The company fully utilises its available capacity.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit

such information before the due date.
