This rating is now an indicative rating and is based on best available information.

BCITS Private Limited (BCITS) was established in the year 1999. It is engaged in the business of providing IT enabled services related to resource provisioning and software development. BCITS which is mainly focused on providing integrated systems for automated Meter Reading, Meter Data Acquisition, Meter Data Analytics & Management, Feeder Monitoring & Supply Analytics, Sub Station Monitoring, Demand Forecasting and Automated Metering infrastructure. The other services that company provides are e-Governance, Cloud Computing, Data Analytics, Smart Grid, Smart City and System Integration. The company caters mainly to the electricity and water boards in Karnataka, West Bengal, Rajasthan and Haryana states. Promoters of the company Mr. Murali Krishna M V and Mr. Sridhar Tummala have experience of more than a decade in the line of business
