Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B (read as ACUITE Bf)rom 'ACUITE B+' (read as ACUITE B plus) on the Rs. 16.00 crore bank facilities of Sun Shine Rice Unit (SSRU) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Sun Shine Rice Unit was established in 2011 as a partnership firm by Mr. Inder Prakash, Mr. Narain Prakash and Mr. Vijay Kumar. SSRU is engaged in processing of paddy into basmati and non-basmati rice. Head office as well as the manufacturing unit is located at Taraori in Karnal (Haryana).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality. This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
