Acuité has reviewed long-term rating of „**ACUITE BB-**” (**read as ACUITE double B minus**) and short term rating of **'ACUITE A4'** (**read as ACUITE A four**) on the Rs. 17.00 crore bank facilities of BHAWANI CASTINGS PRIVATE LIMITED (BCPL). This rating is now an indicative rating and is based on best available information.

#### Non-cooperation by the issuer/borrower

In 2011, the management was taken over by Mr. Ashok Kumar Aggarwal, Mr. Amrish Gupta and Mr. Gaurav Gupta. BCPL manufactures MS billets and TMT bars with a current capacity of 72,000 tons per month.
