Rating Rationale

Acuité has reaffirmed the long-term rating of 'ACUITE D' (read as ACUITE Da)nd short term rating of 'ACUITE D' (read as ACUITE Do)n the Rs 8.75 crore bank facilities of Associated Insulation Company (AIC). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Associated Insulation Company is a Vadodara (Gujarat) based partnership firm established in 1986. The firm promoted by Mr. M.V. Dhuvad and Mr. C.M. Dhuvad is engaged in undertaking thermal insulation works for power plants, oil refineries, petro chemicals units, fertilizer plants and other manufacturing units. AIC is approved and registered with reputed Indian and overseas consultants, including TOYO Engineering India Limited, Engineers India Limited, TATA Consulting Engineers and Samsung Engineering, among others.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
