Acuité has reviewed the long-term rating of 'ACUITE D' (read as ACUITE D) on the Rs. 8.80 crore bank facilities of Dhanlaxmi Cotex (DC). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

DC was established in 2013 as a partnership firm by Mr. Rakesh Patel and family. The firm is engaged in ginning, pressing and processing of cotton bales and seeds. The manufacturing facility is located at Kadi (Gujarat). The company has an installed capacity of processing 150 cotton bales per day.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
