Rating Rationale

Acuite has reaffirmed the long-term rating of ‘**ACUITE B-**’ (read as **ACUITE B minusa**) and the short term rating of ‘**ACUITE A4**’ (read as **ACUITE A four**) on the Rs. 5.50 Cr. bank facilities of Maintec Technologies Private Limited. The rating continues to be flagged as “Issuer Not Cooperating” and is based on the best available information.

About the Company

Maintec Technologies Private Limited (MTPL) incorporated in 1997 is a Bangalore-based company promoted by Mr. Chandra Gupta, Mr. Rajendra Gupta and Mr. Yenamantra Ramachandran. The company provides staffing services to corporates, particularly IT companies. The company has offices at Bangalore, Noida, Pune and Chennai. The present directors of the company are Mr. Chandra Shekar Gupta and Pankaj Kumar Gupta.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.
