Rating Rationale

Acuite has reaffirmed the Short-term rating of ‘**ACUITE D**’ (read as **ACUITE Do**) on the Rs. 7.50 crore bank facilities of Bella Jewelry Private Limited (BJPL). The rating continues to be flagged as “Issuer Not-Cooperating” and is based on the best available information.

About the Company

Mumbai based Bella Jewelry Private Limited (BJPL) was established as a partnership firm in 2004 and converted to private limited in 2007. The company, promoted by Mr. Dauji Johari, Mr Sharadkumar Johari and Ms Prabha Johari, is engaged in the manufacture and export of diamond studded gold jewellery. The company exports its jewellery only to USA.

Non-cooperation by the issuer/borrower:

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuite believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as “Issuer not-cooperating”, in line with prevailing SEBI regulations and Acuite’s policies.

Limitation regarding information availability

This rating is based on information available from sources other than the issuer / borrower (in the absence of information provided by the issuer / borrower) . Acuite endeavoured to gather information about the entity/industry from the public domain.
