Acuité has reviewed its long term rating of '**ACUITE BB+**'(read as **ACUITE double B plus**) and short term rating of '**ACUITE A4+**' (read as **ACUITE A four plus**) to the Rs. 9.00 crore bank facilities of Sonata Ceramica Private Limited (SCPL). This rating is now an indicative rating and is based on best available information.

Sonata Ceramica Private Limited (SCPL) is a Gujarat-based company promoted by Mr. Mukesh Patel, Mr. Jayanti Patel and Mr. Dipak Patel. Incorporated in 2001, SCPL is engaged in the manufacture of ceramic tiles and trading of vitrified floor and wall tiles at Himatnagar, Gujarat. The installed capacity stands at 18 lakh square feet per annum.

Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
