Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE B) from 'ACUITE B+' (read as ACUITE B plus) on the Rs.16.00 crore bank facilities of A J B Leathers (AJBL) on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

AJB Leathers, a proprietorship firm established in the year 2000 manufactures wet blue, finished leathers and East India (EI) leather. The concern has tannery in Dindigul, Tamil Nadu with an installed capacity of 54 lac square feet per annum. The daily operations are managed by Mr. A J Balasubramanian.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.
