Acuité has reviewed the long-term rating of '**ACUITE B** (**read as ACUITE B**) on the Rs.15 crore bank facilities of Vichi Agritech LLP (VALP). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

Established in November 2016, VALP is a limited liability partnership firm established by Mr. Vimal Shah, Mr. Viraj Shah and Mr. Purav Shah. The firm has undertaken a greenfield project for dal processing (toor, moong and chana) at Sokhada Village in Khambhat taluka (Gujarat) with installed capacity of 2 TPH, 3 TPH and 4.50 TPH, respectively.

#### Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with an unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
