Shree Rajendra Agro Industries (SRAI) was established in the year 2011. It is engaged in the business of ginning and pressing of raw cotton and also sells cotton seeds. The firm's manufacturing unit is located at Yadigiri in Karnataka and has an installed capacity of 2 lakhs quintals per annum.

#### Non-cooperation by the issuer/borrower

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.
