Rating Rationale

Acuité has reviewed and downgraded the long term rating to 'ACUITE BB+' (read as ACUITE double B plus) from 'ACUITE BBB-' (read as ACUITE triple B minus) on the Rs. 15.00 crore bank facilities of J K Electro Power. This rating is now an indicative rating and is based on best available information.

J K Electro Power established in the year 2001, is a Kolkata based partnership firm engaged trading of HT / LT Cables & Wires, Cable Jointing, LED Lights & accessories. The partners Sri Kishan Kumar Bagri and Sri Jinendra Kumar Begani are enriched with more than four decades of experience in the related industry. JKEP's head office is located in Kolkata and four branches located in Gujarat, Rajasthan, Chhattisgarh and Orissa. Apart from this the firm has two showrooms located in Bhuvneshwar.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
