Acuité has reviewed long-term rating of **ACUITE B (read as ACUITE B)** and short term rating of '**ACUITE A4 (read as 'ACUITE A four')**' on the Rs. 10.55 crore bank facilities of Jitendra Chaudhary (JC). The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

The Rajasthan-based JC, established in 2008, undertakes short term (i.e. for 1-2 year) toll collection projects through tendering for Rajasthan State Road Development & Construction Corporation Limited. JC is a Class AA contractor.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
