This rating is now an indicative rating and is based on best available information

Ajmera Metals Indore Private Limited (AMPL) was incorporated in 2008. The company is promoted by Madhu Ajmera, Puneet Ajmera and Lalit Bhandari is located at Indore Madhya Pradesh the company is engaged into manufacturing of cold roll formed metal sections, electrical/MCB channel, ball bearing slides, sheet metal components, telescopic channels. The company mainly caters to Automobile Industry, Power Sector and Hardware Industry.
