Acuité has reviewed long-term rating of '**ACUITE B**' (**read as ACUITE B**) on the Rs. 12.00 crore bank facilities of Dhana Laxmi Cotton Industries (DLCI). This rating is now an indicative rating and is based on best available information.

DLCI was established in 2013 by Mr. Y Harishankar, Mr. Y Krishna Murthi, Mr.Y Ramana and Mr. C H Padma. The company is engaged in the ginning, pressing and processing of cotton bales and also lint with installed capacity of 5400 MTPA. The manufacturing unit is located at Parkal (Telangana).

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before due date.
