Rating Rationale

Acuité has downgraded the long-term rating to 'ACUITE B' (read as ACUITE Bf)rom 'ACUITE B+' (read as ACUITE B plus) and reaffirmed the short term rating of 'ACUITE A4' (read as ACUITE A four) on the Rs.12.00 crore bank facilities of Mahesh Rice Mills on account of information risk. The rating continues to be flagged as "Issuer Not-Cooperating" and is based on the best available information.

About the Company

Mahesh Rice Mills, a Haryana-based partnership firm, established in 1993 is engaged in the milling, sorting, grading and processing of rice. The firm procures raw material i.e. paddy and semi processed rice from the local market. Around 70 percent of the products are sold in India and the rest overseas. Most of the revenue in the rice industry comes during November – March. The firm is led by Mr. Mam Chand Goel, Mr. Mukesh Goel, Mr. Ajay Goel and Mr. Parvesh Goel who possess extensive experience in the said line of business.

Non-cooperation by the issuer/borrower:

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer/borrower failed to submit such information before the due date. Acuité believes that information risk is a critical component in such ratings, and non-cooperation by the issuer along with unwillingness to provide information could be a sign of potential deterioration in its overall credit quality.

This rating is, therefore, being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
