Acuité has reviewed long-term rating of '**ACUITE B+** (**read as ACUITE B plus**) on the Rs. 9.50 crore bank facilities of Jin Plast India Limited (JPIL). This rating is now an indicative rating and is based on best available information.

JPIL, incorporated in 1995, is promoted by Mr. Mukesh Kumar Chhalani, Mr. Binith Kumar Chhalani, Mr. Dilip Kumar Chhalani and Mr. Deepak Chhalani. The company is engaged in the manufacturing of plastic crates, drums and household furniture at Sriperumbudur (Tamil Nadu) and has installed capacity of 12 tonnes per day. The company procures raw material such as acrylic, polyethylene, polypropylene from RelianceHaldia Petrochemicals Limited and IndianOil, among others.

#### Non-cooperation by the issuer/borrower

Acuité has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuité's policies.
