Acuite has reviewed long-term rating of 'ACUITE BBB-' (read as ACUITE triple B minus) on the Rs. 7.00 crore bank facilities of Laxmi Steels (LS). This rating is now an indicative rating and is based on best available information.

LS, established as a proprietorship firm in 1996 by Mr. Ashok Patel, is engaged into trading of steel products and non-ferrous metals. The firm sells to various steel companies, wholesalers and traders located mainly in Bhopal, Madhya Pradesh.

Non-cooperation by the issuer/borrower

Acuite has been requesting for data, information and undertakings from the rated entity for conducting surveillance & review of the rating. However, the issuer / borrower failed to submit such information before due date.

This rating is therefore being flagged as "Issuer not-cooperating", in line with prevailing SEBI regulations and Acuite's policies.
